Policies and Procedures for Junior Members

All Junior Members under the age of 14 must be accompanied by an adult age 18 or older, unless their handicap is 12.0 or better or if approved by Head Golf Professional.

If a Junior Member violates any of the golf course rules and regulations, The Ranch Golf Club staff has the authority to contact the junior's parents or guardians and have them removed from the facility.

The Ranch Golf Club is not responsible for supervision of Junior Members during daily operation; it is the responsibility of the Junior Member's parents or guardians to supervise.

Junior Members have access to the golf course all day Monday through Friday and after 11:00 a.m. on weekends and holidays unless accompanied by an adult over 18.
